Description Provides user friendly methods for the identification of sequence patterns that are statistically significantly associated with a property of the sequence. For instance, SeqFeatR allows to identify viral immune escape mutations for hosts of given HLA types. The underlying statistical method is Fisher's exact test, with appropriate corrections for multiple testing, or Bayes. Patterns may be point mutations or n-tuple of mutations. SeqFeatR offers several ways to visualize the results of the statistical analyses, see Budeus (2016) <[doi:10.1371/journal.pone.0146409](https://doi.org/10.1371/journal.pone.0146409)>.

Determines pairs of sequence alignment positions that mutate in a correlated fashion with respect to a consensus sequence.

Details

For every position in the sequence alignment from the FASTA file a Fisher's exact test is applied with every other position in the sequence to check whether at both positions we have correlated mutations with respect to a given consensus sequence. Significant p-values are collected in one big table. `p.adjust` from `stats` package is used for multiple testing correction; corrected values are given as extra column in csv output.

In contrast to `assocpairfeat`, `assocpair` does not use features, but uses a consensus approach. Please be sure, that this is really what you want to use. Otherwise, use `assocpairfeat` or `assoctuple` instead.

A csv file with every possible co-mutation below the given p-value.

Details

Features may be HLA types, indicated by four blocks in the FASTA comment lines. The positions of these blocks in the comment lines are defined by parameters A11, ..., B22. For patients with a homozygous HLA allele the second allele has to be "00" (without the double quotes).

For every position in the sequence alignment from the FASTA file a Fisher's exact test is applied with every other position in the sequence and every HLA-type. Significant p-values are collected in

one big table. `p.adjust` from `stats` package is used for multiple testing correction; corrected values are given as extra column in csv output.

In contrast to `assocpair`, `assocpairfeat` uses an analysis with 'features' without a consensus sequence.

Table with all alignment position pairs with significant association with sequence feature.

Details

For each sequence alignment position (each column of sequence alignment), Fisher's exact test is evaluated for a 2-by-2 contingency table of amino acid (or nucleic acid) vs. feature. The resulting p-values are returned in a table. p-values can be corrected for multiple testing using various methods (option `multiple_testing_correction`).

If `bayes_factor` is TRUE, a simple calculation of a bayes_factor is applied instead of the Fisher's exact test. An independent model is compared with a nearly independent model (see. Mixtures of Dirichlet Distributions and Estimation in Contingency Tables). The user can choose if a fixed dirichlet precision parameter or a calculated one should be used. The calculated dirichlet precision parameter is dependend from the number of entries in the 2-by-2 contingency table. For more information see the mentioned paper and "Bayesian Computation with R". With Bayes Factor a usage of multiple testing is not possible (and in most of all cases not needed). If `constant_dirichlet_precision_parameter` is FALSE, the Dirichlet precision parameter K for the calculation of the Bayes Factors is calculated by the system.

The input sequence alignment may be consist either of DNA sequences (switch `dna = TRUE`) or amino acid sequences (`dna = FALSE`). Undetermined nucleotides or amino acids have to be indicated by the letter "X".

A phylogenetic bias check can be made if `bayes_factor = FALSE` and the result added as an extra column to the csv result file. For each alignment position with a p-value below a user given threshold (`optical_significance_level`), the mean distance of all sequences with the mutation, which gave rise to this p-value, is calculated and compared with the mean distance of all sequences.

Features may be either a single feature, or HLA types, the latter indicated by four blocks in the FASTA comment lines. The positions of these blocks in the comment lines are defined by parameters A11, ..., B22 (..C22 if there is information about the C allele). For patients with a homozygous HLA allele the second allele has to be "00" (without the double quotes). For single features (no HLA types), set option `one_feature=TRUE`. The value of the feature (e.g. 'yes / no', or '1 / 2 / 3') should then be given at the end of each FASTA comment, separated from the part before that by a semicolon.

Value

The function generates various types of output: a table of p-values, p-values corrected for multiple testing, z-scores, amino acid with the lowest p-value at this position, result of the phylogenetic bias test, and several plots. A Manhattan plot is generated for each feature in a pdf file with alignment positions on the x-axis and p-values on the y-axis. Two different significance levels can be indicated by a line (`optical_significance_level`) and the change from the normal dot symbol to a star (`star_significance_level`).

In case of `bayes_factor = TRUE`, the Bayes Factor and not a p-value and the estimate of the simulation standard error of the computed value of the Bayes factor is given.

Optionally (`epi_plot = TRUE`), a second plot is provided with the number of 'significant' p-values or Bayes Factors (value of significance chosen by `optical_significance_level`) in a sliding window of `x` amino acids (`x` can be any number from 1 up to the length of the alignment chosen by '`window_size`'). The typical length of an MHC I binding motif is nine). Each point in this plot is the number of 'significant' p-values or Bayes Factors in the next `x` alignment positions. Additionally, with given HLA motifs (`path_to_file_binding_motifs`), a second line is added. This line shows potential epitopes. A potential epitope is assigned if a 'significant' p-value or Bayes Factor (value of significance chosen by `optical_significance_level`) is inside one of the motifs for this HLA type.

Details

For a given alignment a simple hierarchical model (amino acids/ nucleotides at each position are multi-nominally distributed, features are gamma(0.1,0.1) distributed - see example file).

The input sequence alignment may be consist either of DNA sequences (switch `dna = TRUE`) or amino acid sequences (`dna = FALSE`). Undetermined nucleotides or amino acids have to be indicated by the letter "X".

Features may be either a single feature, or HLA types, the latter indicated by four blocks in the FASTA comment lines. The positions of these blocks in the comment lines are defined by parameters A11, ..., B22. For patients with a homozygous HLA allele the second allele has to be "00" (without the double quotes). For single features (no HLA types), set option `one_feature=TRUE`. The value of the feature (e.g. 'yes / no', or '1 / 2 / 3') should then be given at the end of each FASTA comment, separated from the part before that by a semicolon.

However a user can add his own model and parameter (only for EXPERTS!): The jags model file has to be given as 'own_model'. This 'activates' the following parameters: 1. Further, the user can add other response data ('further_response_data') besides the internally already given matrix with all amino acids/nucleotides at every position and every feature and the colSums of this matrix. 2. The user has to insert initial values ('response_inits') and 3. response parameters ('response_parameters'). For the definition of initial values the following variables can be used: - `all_of_letters` = all amino acids/nucleotides plus gap symbol and unknown (X) - `min_FASTA_length` = length of alignment - `allels` = all HLA-allels/features A response parameter named theta will be evaluated by the part of the program after the model, therefore the user should keep in mind to name this in his own model: The result theta has to be of the following form: 3 dimensional, with first dimension: feature vs no feature, second dimension: amino acid/nucleotide, third dimension: position (see examples file).

Value

The function generates various types of output: a table of probabilities, z-scores, amino acid/nucleotide with the highest probability at this position and several plots. A Manhattan plot is generated for each feature in a pdf file with alignment positions on the x-axis and probabilities on the y-axis. Two different significance levels can be indicated by a line (`optical_significance_level`) and the change from the normal dot symbol to a star (`star_significance_level`).

Optionally (`epi_plot = TRUE`), a second plot is provided with the number of 'significant' p-values (value of significance chosen by `optical_significance_level`) in a sliding window of x amino acids (x can be any number from 1 up to the length of the alignment chosen by 'window_size'. The typical length of an MHC I binding motif is nine). Each point in this plot is the number of 'significant' probabilities in the next x alignment positions. Additionally, with given HLA motifs (`path_to_file_binding_motifs`), a second line is added. This line shows potential epitopes. A potential epitope is assigned if a 'significant' probabilities (value of significance chosen by `optical_significance_level`) is inside one of the motifs for this HLA type.

Note

To uses this function, it is essential to install Jags. This seems to be easy for Windows and Linux systems, but complicated for MacOS. Therefore this function is not tested in installation process.

Details

Takes the results from assocpoint and assocpair/assocpairfeat and tries to combine them into one result: we are looking for pairs of sequence alignment positions where (a) each of the positions is significantly associated with the feature (for significance level see parameter `significance_level`), and (b) the sequence states of both positions are associated. Pairs of positions fulfilling these two criteria may e.g. carry compensatory mutations. If at least one such mutation is found, a detailed output is additionally created with possible compensatory mutations

A csv file with p-value for alignment position pairs and if existing a csv file with possible compensatory mutations.

Details

For each tuple of sequence alignment positions, Fisher's exact test is evaluated for a 2-by-2 contingency table of amino acid tuple (or nucleic acid tuple) vs. feature. The resulting p-values are returned in a table.

For this to work properly the result from SeqFeatRs `assocpoint` can be used, but also a user generated csv file in which at least one column describes the sequence position and another the p-value at this position, as well as a FASTA file from which those file originated.

assotuple takes only those sequence positions which have a p-value lower than the given threshold ('threshold'). Be aware that for big datasets the calculation time can be high and a calculation of every position with every other position will most definitely result in low quality data.

Please be also aware that it just uses the position in your csv file. If this is NOT the correct position, because of removal of empty or near empty alignment positions, correct the csv file before starting.

Use the same FASTA file you had used for `assocpoint`!

The sequence positions to be included in this analysis are normally chosen from the corrected p-values (but can be anything else as long as it is between 0 and 1, even an own added column). The size of the tuples can be anything from 2 to number of rows (= number of alignment positions) in the csv input file. The input sequence alignment may be consist either of DNA sequences (switch `dna = TRUE`) or amino acid sequences (`dna = FALSE`). Undetermined nucleotides or amino acids have to be indicated by the letter "X".

Features may be HLA types, indicated by four blocks in the FASTA comment lines. The positions of these blocks in the comment lines are defined by parameters A11, ..., B22. For patients with a homozygous HLA allele the second allele has to be "00" (without the double quotes). For non-HLA-type features, set option `one_feature=TRUE`. The value of the feature (e.g. 'yes / no', or '1 / 2 / 3') should then be given at the end of each FASTA comment, separated from the part before that by a semicolon.

The analysis is done only for one single feature. This is chosen by either 'feature' if there is only 'one_feature', or `column_of_feature` if there are HLA types.

For every feature (if only one p-value is below given threshold ('significance_level')) an output page (pdf page) is created with a sequence position versus sequence position graphic. Every dot color(one position with the other position) is based on its p-value. The color code is on the right side.

Only use files generated from SeqFeatRs assocpairfeat function.
